

HORSE PERMIT APPLICATION 2023-2024

You are invited by the Balnarring Beach Foreshore and Parks Reserve Committee of Management Inc. (CoM) to apply for a Horse Permit for 2023-24. This application should be read in conjunction with the Horse Permit Conditions 2023-24 and the Horse Permit Area Map 2023-24 (see attachments).

Please note:

1. Applicants may have their applications rejected if the CoM consider the applicants to be making multiple applications on behalf of any Individual, Company or Entity.
2. There are a maximum of 40 Commercial Permits available. Commercial Permit Holders will be guaranteed 1 permit if they currently hold up to 2 permits and 2 permits if they hold 3 or more permits. Permits beyond that will be decided by ballot.
3. Individuals and Companies (including their employees) may hold a maximum of three permits.
4. There are 8 Family and a minimum of 42 Local Recreational Horse Permits available. Riders missing out on those permits will be included in the ballot for a Standard Permit. If successful these persons will be eligible to pay the Local Recreational Permit Fee.
5. There are a maximum of 10 Standard Permits available. If there are more than 10 applications received these will be decided by ballot.
6. Applications close at 4pm on Friday 26th May 2023. Applications received after that date will be placed on a waitlist.

We offer four types of Horse Permits. Please mark the number and **preferred** type of permit in box:

- Local Recreational Horse Permit (\$150)** – 1 horse and 1 or less rides per week.
- Family Horse Permit (\$450)** – Up to 4 horses all year round (1 or less rides per week).
- Standard Horse Permit (\$750)** - Year round use except Sundays.
- Commercial Horse Permit (\$750)** – Commercial use year round except Sundays. Commercial permits are only available to VRC Trainers or FEI Members and affiliates. If you are applying for more than 1 permit, please place the number of permits in the box provided.

Indemnity

1. The permit holder HEREBY FOREVER RELEASES, DISCHARGES, INDEMNIFIES and HOLDS HARMLESS the Crown in the right of the state of Victoria, its servants and agents and the secretary as the body corporate of the Department of Environment, Land, Water and Planning, its servants and agents and independent contractors employed by the Crown and/or the Department and the Committee of Management of the Balnarring Foreshore Parks and Reserve Incorporated.
 - a. From any Legal Liability whatsoever arising from the participation or use by the permit holder and/or any other persons associated with the permit holder at Balnarring Beach in the activity of conducting horse on the beach and in all activities in connection therewith.
 - b. From any and all loss, damage, expenses, claims, demands, actions and cause whatsoever which might be made or instituted or suffered or incurred or sustained by any person or body for injury, loss or damage arising in any manner for the said participation or use.
 - c. For all loss or damage to any property, building, equipment or materials of the Department and/or any other persons on or outside the location caused by the permit holder and/or any person associated with the permit holder due to the said participation or use.
 - d. From any and all loss, damage, injury or illness, including death, sustained or incurred by the permit holder and/or any persons associated with the permit holder arising in any manner from the said participation or use.
2. The permit holder AGREES:
 - a. To maintain a public liability policy of insurance for an amount of not less than \$10 million with an insurer authorized under the *Insurance Act 1973*;
 - b. That the public liability policy of insurance include as a named insured the Crown in the right of the State of Victoria, its servants and agents and the Secretary as the body corporate of The Department of Energy, Environment and Climate Action, its servants and agents and Independent contractors employed by the Crown and/or the Department and the Committee Acting in its capacity as Committee of Management for Balnarring Foreshore and Parks Reserves Incorporated;
 - c. That the public liability policy of insurance includes a cross liability clause and waiver of Subrogation for the named insured at (b) above;
 - d. That a copy of the currently maintained public liability policy of insurance be provided to The Balnarring Foreshore and Parks Reserve Committee of Management Inc.
3. The permit holder AGREES:
 - a. To observe the Horse Permit Regulations 2023-24 as attached to this agreement or as updated by the Balnarring Beach Foreshore Committee of Management.
